## THE DALE-ENGLE-WALKER HOUSE 1471 Strawbridge Road, Lewisburg, PA



The Dale-Engle-Walker House will be open on Sundays, June 27, July 18 and 25, August 15 and 29, and September 11 and 26, with free tours at 12 noon and 2 p.m.

The historical society is pleased to be able to again host visitors at the house after so many months being closed due to COVID-19.

Learn how the story of Samuel Dale and the Dale-Engle-Walker House are intertwined with the Susquehanna Valley's history. The house, built by Scots-Irish immigrant Samuel Dale c. 1793, was rented

to tenant farmers for many years and remained in the Dale family until 1929. Jacob and Maude Engle purchased the property for their dairy farm and made improvements during the 1940s to the house and land, adding an orchard, vegetable and flower gardens. "Charlie" Walker, professor at Bucknell University, and Rosie Walker, a master gardener, purchased the property in 1957. In 2001 the house was given by the Walker estate to the Union County Historical Society which has worked to preserve and restore the house. The house sits on a hillside overlooking agricultural fields in Buffalo Township with Buffalo Creek about 100 yards to the north and Dale's Ridge to the west. The Merrill W. Linn Land and Waterway Conservancy maintains the Dale's Ridge Trail.

Tours are open to the public and free of charge, although donations are appreciated.

### MILNE-DRUCKENMILLER CABIN

The Milne cabin, built c.1789 as a frontier trading cabin on the Tuscarora Indian Path at Middlecreek, came into Marcia Kantz Milne's family in 1803, when Christian Kantz purchased it from Peter Druckenmiller. The cabin was restored by Kantz descendants in 1998 when it was moved to Marcia and David Milne's property in Lewisburg. Interested in preserving this important early structure, Marcia Milne donated the cabin to the historical society in 2019. The cabin was dismantled, reassembled and restored at the Dale-Engle-Walker property where it presents a fuller story of the site. When Samuel Dale purchased the property in 1785, there was a log cabin in which the family lived before construction of the limestone house.

Dedication of the historic cabin is planned for September 11, 2021. Watch for more on this event in our next newsletter, announcements to members, and articles in the local newspapers.



Dear Society Members and Friends,

The world can learn much from the past when dealing with this recent public health crisis. For example, it's always astounding how quickly people invoke a vague notion of the Founding Fathers whenever they need to justify dubious judgment, attitudes, and behaviors.

The question is, which Founding Father?

When George Washington commanded the Continental Army, he knew that smallpox could kill soldiers and quickly ruin an army's effectiveness. As a pre-emptive measure during the early years of the Revolution, he ordered all recruits to be inoculated through a crude method known as "variolation." Despite some political grousing, the strategy worked and significantly reduced fatalities.

Let's look at Union County's own Samuel Dale. For nearly 30 years, he served the citizens of north-central Pennsylvania, first as a state representative, then later as a state senator. Dale voted with the majority of the legislature to outlaw "building a playhouse, theatre, stage or scaffold for acting, shewing, or exhibiting any tragedy, comedy, farce, interlude, pantomime or other play." But this vote wasn't necessarily because Dale disapproved of entertainment. After all, he owned nine volumes of Shakespeare's plays. It was most likely intended to prevent the spread of smallpox and other highly communicable diseases in crowded venues.

We can trace other commonly held beliefs directly to the past. Throughout the nineteenth century, public health officials fought smallpox with the cowpox vaccines developed by Edward Jenner. Despite the campaign's success, editorial cartoons, news articles, and pamphlets written by Dr. William Rowley claimed that children born to inoculated mothers had ox-shaped heads and bulging "cow eyes." Other anecdotes insisted that those who received vaccinations had horns growing out of their heads, or worse, engaged in bestiality.

We also find that citizens objected to wearing face masks during the 1918 influenza pandemic. Medical historians, though, argue that this reluctance may have contributed to two powerful reoccurrences throughout 1919 and 1920.

When we register for public school, when we enlist in the military, or when we travel overseas, we need inoculations to protect ourselves and others. How far do you think you would go if you argued otherwise with your commanding officer, your school officials, or with airline pilots?

As even Ecclesiastes tells us, "There's nothing new under the sun." Maybe that's why history matters, too.

## SHIKELLAMY MONUMENT REDEDICATION at Central Oak Heights

On Sunday, August 1, 2021, at 2:00 p.m., the Union County Historical Society, along with representatives from Central Oak Heights, will rededicate the historic monument commemorating Chief Shikellamy on the grounds of Central Oak Heights (just south of West Milton).

The monument is located on the bluff overlooking the site of Shikellamy's Old Town, which lay in the valley to the south of the hill. The event will recognize the one hundredth anniversary of the date on which the monument was originally dedicated, August 2, 1921. That event included representatives of the United Evangelical Historical Society, the Union County Historical Society, and the Pennsylvania Historical Commission. The proceedings on August 2 will include an address by UCHS President Bruce Teeple, outlining the history of Native Americans in our area and the significance of Chief Shikellamy (died December 17, 1748).

Please plan to attend this event, co-sponsored by UCHS and Central Oak Heights, as we celebrate one of Union County's important historic sites. (Directions: from West Milton, take Rte 15 south to the entrance to Central Oak Heights.)

## Union County Historical Society 2022 *Heritage* Publication

Our next *Heritage* publication, about Union County during the Civil War, is by our friend and long-time society member Rick Sauers (past director of the Packwood House Museum in Lewisburg), current curator of the Western Museum of Mining and Industry in Colorado Springs, Colorado ([wmmi.org](http://wmmi.org)).

Rick is using his extensive knowledge of Civil War history and his expertise in primary source research to comb Union County newspapers, diaries, letters, and other accounts from the Civil War era to tell the story and provide the context for an analysis of Union County's Civil War experience.

The Archives Committee would like to thank everyone who donated and gifted to the society since January of this year. Your gifts and donations to the collection of materials held by the society supports its mission of enhancing the appreciation and visibility of Union County history.

**Anonymous donation:** framed tavern license issued to Christian Fisher of Penn Township, Union County (now Snyder County) signed by Simon Snyder, Jr., Clerk of the Court of Union County located in New Berlin, on June 13, 1815. The license was good for one year at a cost of \$8.80.

## Forest School Day Camp at the Dale-Engle-Walker Property

"The more high-tech our lives become, the more nature we need."

Richard Louv, author of *Last Child in the Woods*

As schools were forced to shift to virtual learning due to the coronavirus pandemic, another group was immediately affected: student teachers. Even as schools reopened, the requirement to limit the number of people in the classroom meant that universities were challenged to find opportunities for teacher candidates to work directly with children, a requirement for graduation.

Recently, the Dale Engle Walker property became part of the solution to this challenge, serving as the ideal site for Forest School Day Camp, a new outdoor education program for homeschooled children ages 4-9 offered weekly on Thursdays. This community outreach program, offered to any interested family regardless of ability to pay, represents a collaboration between the Union County Historical Society, Merrill Linn Conservancy, Bucknell University's Education Department, Lewisburg Children's Museum, and outdoor educator Susan Chlebowski.

Forest School Day Camp is modeled after Scandinavian and UK Forest Schools, and the growing US model of "Forest Days", where each child spends a half day in the woods each week engaged in child-led, hands-on learning, play and skill building. Junior Bucknell education students serve as facilitators and have the opportunity to observe children in a setting that has shown to improve behavior, increase focus and concentration, and bring out skills and competencies that may not be observable in indoor settings. Teacher candidates will also have the opportunity to connect outdoor learning activities to state standards and required teacher preparation competencies. The short documentary *Best Day Ever*, profiling forest kindergartens in VT public schools, describes the model.



Forest School Day Camp also benefits local children who have limited opportunity to socialize and learn with other children during the pandemic. The program was held through the spring, and the children easily adapted to learning and playing in a fully outdoor experience in all types of weather. This model also reflects an alternate role of the teacher, one in which teachers step back and let children self-direct their play and learning through child-led activities based on the children's interests, curiosity and observations of the natural world.

The evidence-based methods (nature combined with child-led play and learning) used in this program reflect research that shows that these programs benefit children in many ways, including improved holistic health (physical, mental, social, emotional) and improved confidence, independence, motivation, problem solving, and critical thinking. Learning outdoors also supports a child's complex sensory and motor needs, enhances cognitive and academic learning, and fosters lifelong respect and care for the natural world.

Across the country, outdoor educators and national organizations promoting outdoor learning have scaled up rapidly and openly shared resources to create outdoor classrooms and programs to bring students and teachers outside. Locally, the Forest School Day Camp at the Dale Engle Walker property is one example of cooperative, flexible problem solving within our community, creating a solution that brings safe play and learning to children and broadens the experience of student teachers, preparing them to be part of a growing worldwide movement to expand learning beyond the classroom walls.

I've been overwhelmingly grateful as I spend time at Dale-Engle-Walker for the beautiful property that you have shared with us.

## ARCHIVES & COLLECTIONS NEWS

The UCHS Archives includes a large collection of reel-to-reel tape recordings (a little over 300) of interviews that were done as part of the Oral Traditions project between 1975 to around 1985. The committee would like to transfer the tape data to a digitized format, thereby preserving the voices of those interviewed and making the information available to researchers. Reel-to-reel tapes deteriorate over time and we'd like to preserve the historical data before it is lost.

We are appealing to the membership for financial assistance with this endeavor through member donations. The company doing the work is offering a 50% discount at the moment so we can digitize 80 tapes at a cost of \$1,200. The total project cost is about \$4,000.
