## Secretary's Report

- On a motion by Louise and Kathy, the Board approved the minutes of the May Board meeting as submitted.

# Treasurer's and Financial & Programming Administrator's Report

- Online viewing of bank accounts Matt has arranged for designated Board members to view our bank accounts.
- IRS penalty Dan and Matt will speak with political representatives and Brubaker's to appeal for forgiveness and reimbursement. UCHS has also applied for extending submission of our 2019 form. The Board will make final arrangements at our September meeting.
- PHMC grant Dan reported that the check should arrive next week.
- Update on bill from county (see report)
- Update on insurance coverage (see report). Louise also offered to review the policy.
- Bruce will schedule a Finance Committee Zoom meeting in August to discuss the 2020 budget.
- Louise suggested sending a general appeal for donations. Dan added that he could post appeals along the Dale's Ridge Hiking Trail. We will discuss more at the Finance Committee meeting.
